Fixing America's Surface Transportation (FAST) Act, requires that the Metropolitan Planning Organizations prepare an annual listing of projects, including investments in pedestrian walkways and bicycle transportation facilities, for which Federal funds have been obligated in the preceding year. The listing shall be published or otherwise made available by the cooperative effort of the State, transit operator and metropolitan planning organization for public review. The listing shall be consistent with the funding categories identified in each metropolitan Transportation Improvement Program (TIP).

The following tables provide information on transportation projects in the Owensboro – Daviess County MPO that have been obligated for spending using federal funds during fiscal year 2017—October 1, 2016 through September 30, 2017. The Owensboro – Daviess County MPO area includes the City of Owensboro and Daviess County, Kentucky. Please note some projects may have received federal authorization in the previous fiscal year, but were not let until the current fiscal year.

The information provided here is consistent with how projects are listed in the Owensboro – Daviess County TIP, i.e. projects are shown with a project identification number, route, section, location and description of project and funding amounts. The information that is shown includes the federal funding source, the amount of federal funds that were included in the Transportation Improvement Program

Project obligation information is also provided for the Owensboro Transit System (OTS).

An obligation is the federal government's legal commitment to pay the federal share of a project's cost. An obligated project is one that has been authorized by a federal agency, such as the Federal Highway Administration (FHWA) or the Federal Transit Administration (FTA). Obligated projects are not necessarily initiated or completed in the programmed year and the amount of the obligation may not necessarily equal the total cost of the project. For FTA projects, obligation occurs when the FTA grant is awarded. For FHWA projects, obligation occur when a project agreement is executed and the state/grantee requests that the funds be obligated.
